

Your Practice Your Way

- Providing dental care for people with Medicaid coverage doesn't have to change your practice
- Adding Medicaid as a payor can help you serve your community, while you keep running your practice in a way that works for you



Medicaid Population

Who has Medicaid coverage?

- People with low income are eligible for Medicaid:
 - Children, including kids in foster care
 - Pregnant women
 - People with disabilities
 - Older adults
- All people with Medicaid insurance have dental coverage, including adults



Decide on your practice's limits

- A dental office can limit its Medicaid in a way that makes sense for you
 - Geography (city, county, region)
 - Age (children, adults)
 - Population (children, adults, people with disabilities, older adults)
 - Number (10, 25, 100, or more patients)
 - Percent (5%, 10%, 25%, or more patients)
- One thing is not allowed: You cannot put limitations on Medicaid patients you would not put on others



Contracting with the MCOs

Who are the MCOs?

- The Kansas Department of Health & Environment contracts with three managed care organizations to provide Medicaid services
- Next week you will get to meet the MCOs and learn more about each







Decide on your practice's limits

- Each dental office can choose to contract with one, two, or all three of the MCOs
- You enroll with KDHE to be a Medicaid provider, and then work with the MCOs to sign contracts with the ones you choose



Missed Appointments

Missed Appointments

- Every dental office deals with missed appointments with all patient populations
- It's possible to manage with policies that would apply to all patients
- Only one thing is not allowed:
 - Cannot charge a fee for a Medicaid patient who cancels or misses an appointment



Strategies to Mitigate Missed Appointments

- Set expectations about why it is important to keep appointments
- Create a missed appointment policy that applies to all patients
 - For example, set a three strikes policy if someone is late or fails to cancel
 - After three strikes, they would go on a waiting list if there are cancellations or if there is an emergency



Strategies to Mitigate Missed Appointments

- Text and/or phone reminders for appointments, including extra reminders on the morning of the appointment
- Work with the MCOs to use services they have, which could even include appointment reminders



Helping Patients with Barriers

Transportation Services

- Transportation is a barrier for some Medicaid patients
- Medicaid covers "non-emergency medical transportation" for dental visits
- A dental office can work with the MCO and the patient to schedule a ride
- The MCO should be contacted at least three days before the appointment




We don't always know the back story

- Many people with Medicaid coverage may have gone a long time without care, so going to dental appointments may not be a habit yet
- Providing education about the importance of regular care could help people make the appointments a priority
 - Medicaid covers D1330 for oral hygiene instruction – this may help with education about the importance of dental care




A Medicaid Dental Provider's Perspective



2024 Medicaid Dental Provider Network

- A small number of dental providers in the state are Medicaid providers
- Medicaid is like any other insurance, and the improvements in coverage and rates have made big changes in how it works
- There are resources for providers and consumers to help make Medicaid work better for everyone

Strategies to reduce missed appointments

The American Dental Association (ADA) recognizes that practice efficiency and full patient schedules are high priorities for dentists. This document outlines strategies to consider for dentists participating in Medicaid to maximize practice productivity, decrease patient cancellations and missed appointments, and reduce administrative burdens.

Strategies for Dentists to Reduce Patient Cancellations and Missed Appointments

- Engage in patient support strategies offered by the managed care organization (MCO) to provide transportation services, appointment reminders, and increased oral health literacy to Medicaid beneficiaries. Dental practices should have access to these resources based on the patient's MCO and use these resources proactively. It is also important to remember that MCOs may pay for transportation and a cancelled or missed appointment is a part of a costly cycle for the MCOs, as well.
 - Conversing with patients on expectations, practice protocols, and the necessity of not missing the appointment is a great strategy and must be delivered with civility and without implicit bias. A reappointment policy and an emergency walk-in policy are useful practice tools to offer patients.
- Incorporate scheduling best practices to align with your practice model and protocols.
 It is important to note that despite the desire to charge a fee for a cancelled or missed appointment,
 Medicaid beneficiaries are excluded from such charges due to federal statutes and regulations.

Strategies for reducing missed appointments include setting expectations for compliance and engaging the MCO in the process.

Transportation

- To help a patient schedule a ride to a dental appointment, contact their MCO
- The phone number is on the back of the patient's KanCare ID card


